## E-TENDERING NOTICE

Communication & Works, Department, Highway Division, Sahiwal intends to tender out the following scheme through newly introduced E-Tendering Systems, vide notification No.SOE-I(C&W)1-49/2023/3652, dated 26-05-2023.


All Contractors who are registered with Pakistan Engineering Council (PEC) can to participate in open E-Tendering System. Procurement procedure will strictly be adopted in accordance with PPRA Rules 2014. Contractors can participate in E-Tendering after fulfilling following terms & conditions:-

1. Contractor may register firms on website [www.ecnw.punjab.gov.pk](http://www.ecnw.punjab.gov.pk) of Communication & Works Department, Lahore by submitting their requisite information.
2. After registration on E-tendering website [www.ecnw.punjab.gov.pk](http://www.ecnw.punjab.gov.pk) contractors of eligible categories may participate in E-Tendering.
3. Contractor may generate the tender Fee Challan (32-A) / Payment slip ID (PSID) mentioned below. Contractor Bidder has to upload scanned copy of payment receipt on contractor portal and payment receipt shall be required to submit in the office of undersigned before tender opening time.
4. Requisite Tender fee be received collected through E-Pay Punjab Mobile Application with **Highways Works Code: CO2716**.
5. After uploading the tender Fee Challan paid voucher, contractor / bidder has to upload scanned copy of Call Deposit Receipt (CDR) @ 2% of the estimated cost of any scheduled bank, on website. Original CDR must be submitted to the office of undersigned on tender opening date before opening time.
6. Contractor has to quote online percentage rates on below or above basis upto **13-06-2024 at 02:00 P.M** after reviewing B.O.Q of the scheme available at website. The rates quoted online by the contractor will be downloaded from website and will be announced on same date at **02:30 PM**.
7. All the contractors participated in E-Tendering will be bound to submit their Original CDRs, paid tender fee Challans with letter heads in the office of the undersigned. Otherwise, the contractor will be declared as disqualify in the presence of Tender Opening Committee.
8. In case of false information, fake CDR & fake tender fee Challan, the contractor will liable to disqualify as per PPRA Rules and will not be eligible to participate in upcoming tenders of C&W, Department, Govt. of Punjab. Further his case will be forwarded to PEC and PPRA for initiation of Strict Legal Action.
9. In case the lowest bidder whose bid will be more than 5% below of DNIT of the work, the lowest bidder will be bound to deposit the difference between the bid & estimated cost as per rate quoted by the Bidder as Additional Performance Security in shape of Call Deposit or Bank Guarantee from any schedule bank within **15-Days** after opening of tender. Lowest bidder will have to upload the CDR or Bank Guarantee on the website & will submit the original CDR f Bank Guarantee in the office of Undersigned, otherwise the tender of the lowest bidder will stand cancelled & earnest money will be forfeited in favour of the Govt.

- Note:- 1) It is for the information of every interested applicant/bidder that the sanctioned rate of RCC/Rigid Pavement is inclusive of cost of concrete batching plant as well as concrete laying paver/concrete paving machine. It must be noted that successful bidder will be required to execute the Rigid Payment work by use of batching plant and concrete laying paving machine etc.
- 2) Due to system up gradation, recovery against credit of old material will be adjusted manually and accordingly bids will be reevaluated.
  - 3) Any application received through courier /post or through email will not be considered/accepted.
  - 4) The procuring agency may reject all bids or proposal at any time prior to the acceptance of a bid or proposal under PPRA Rule-35 (Rejection of Bids).
  - 5) As per clarification from Finance Department No Price Variation is admissible on Maintenance & Repair Work & Clause 55 of standard contract agreement is not applicable.
  - 6) It must be noted that rigid payment will be laid by use of batching plant and proper paver.
