Also provide affidavit under taking that all the information provided are true / correct and if found in correct proper action will be initiated. - 7. The firm/contractors who quote rate beyond 10% below shall also provide rate analysis duly signed by the Electrical Engineer registered along with PEC registration Number and the rate analysis will be provided in the technical proposal envelop.

- 8. The firm/contractors who quote rate beyond 10% below shall also deposit 8% additional call deposit (No Bank Guarantee is acceptable) on estimated cost in the name of undersigned as per KPPRA rules.
- 9. The bidder will provide an affidavit in the technical proposal that no Water Supply Scheme should stand un-operational for more than 24 hours. For which he should arrange sufficient stand by Pumping Machineries / other accessories/arrangements.
- 10. All other terms and conditions will be as per KPPRA rules, PEC, SBDs and other relevant laws.
- 11.All the bidders are required to be registered with the Khyber Pakhtunkhwa Revenue authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services as listed in schedule-II of the Act ibid).
