2. Last date & time of submission of the bid is **23.07.2024 at 12.00 (Noon)** which will be opened on the same day at **2:00 PM**, in presence of the contractors or their authorized representative, who opt to attend.
3. The eligible bidders are required to send their bids through courier services or by hand along with their PEC / Renewal for 2024-25 and hard copies of all relevant documents.
4. The Bidders who quote Rates "More than 10% below" on the BOQ shall Deposit additional Call Deposit in form of percentage on estimated cost with the bid, And they shall also submit Rates Analysis attached with bids duly certified by Engineer In-Charge of their Firms, otherwise without additional CDR and rate analysis the bid will be considered as non-responsive and straight away will be rejected.
5. After opening of technical bids, the detail scrutiny of documents of the bidders will be carried out, the mandatory hard copies of the following documents must attach with the bid, if the bidder fails to submit any of the following mandatory hard copies of the following documents, the bid will be non-responsive and straightaway will be rejected.

CNIC Copy of the Bidder ii. BOQ Downloaded from net iii. Valid PEC registration of the bidder iv. Valid enlistment certificate from works department v. FORM H in case of companies vi. Valid KPPRA online verification form vii. Valid FBR online verification form viii. The bidder will provide the certificate on Affidavit that the firm is not involve in any Litigation case with PHE Division DIKhan ix. Rate analysis in case of quoting rate more than 10 % below on Engineer cost estimate duly certified by the firm Engineer x. additional call deposit in shape of CDR as Per KPPRA rules xi. In case of Tube drilling work the proof of ownership of Drilling Machinery OR Joint venture with the drilling machinery owner xii. Tender fee @0.03% on bid cost in shape of CDR.

6. All other terms and conditions will be as per KPPRA rules, PEC, SBDs and other relevant laws.
7. Govt Taxes shall be applied as prevailing.
8. No bank Guarantee is acceptable to this office.
9. Only the contractor who has been registered with Khyber Pakhtunkhwa Revenue authority will be allowed to participate in the tenders.
