

## **E-TENDERING NOTICE**

Communication & Works Department, Highway Division Taunsa intends to tender out the following scheme through newly introduced E-Tendering vide Notification No.SOH-1/(C&W)1-49/2023/3652 dated 26.05.2023.

All Contractors who are registered with Pakistan Engineering Council (PEC) in relevant category can to participate in Open E-Tendering System. Procurement procedure strictly be adopted in accordance with PPRA Rules 2014 (with upto date amendments). Contractors can participate in E-Tendering after fulfilling following terms & conditions:

1. Contractor may register firm on website [www.ecnw.punjab.gov.pk](http://www.ecnw.punjab.gov.pk) of Communication & Works Department, Lahore by submitting their requisite information.
2. After registration on E-Tendering website [www.ecnw.punjab.gov.pk](http://www.ecnw.punjab.gov.pk) contractor of eligible categories may participate in E-Tendering.
3. Contractors may generate the Tender Fee Challan (32-A) / Payment Slip ID (PSID), amount of work. Contractor / Bidder has to will upload scanned copy of payment receipt on contractor portal and payment receipt shall be required to submit in the office of undersigned before tender opening time.
4. Requisite Tender fee be received / collected through e-pay Punjab Mobile Application with Highway Works **Code C02716 Revenue Receipt (Highway)**.
5. After uploading the tender fee challan paid voucher, contractor / bidder has to upload scanned copied of Call Deposit Receipt (CDR) @ 2% of the bid amount cost of any scheduled bank, Original CDR must be submitted to the office of Executive Engineer, Highway Division, Taunsa on tender opening date before closing time.
6. Contractor has to quote online percentage rates on below or above basis **upto 28.06.2024 at 11:30 AM** after reviewing B.O.Q of the scheme available at website. The rates quoted online by the contractor will be downloaded from website and will be announced on same date at **12:00 PM**.
7. All the contractors participating in E-Tendering will be bound to submit their Original CDRs, paid tender fee challans with letter heads in the office of the Executive Engineer, Highway Division, Taunsa, otherwise the contractor will be declared as disqualified in the presence of Tender Opening Committee.
8. In case of false information, fake CDR & fake tender fee challan, the contractor will be liable to disqualify as per PPRA Rules and will not be eligible to participate in upcoming tender of C&W, Government of the Punjab. Further his case will be forwarded to PEC, PPRA & Rules for initiation of strict legal action.
9. The procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.
