- Ambiguous / Conditional tenders and tenders not accompanied with earnest money @ 2% of the bid cost in shape of CDR of any scheduled Bank and applications not accompanied with attested copies of registered partnership deed and power of attorney in case of firms will not be entertained.
  - In case the total tendered amount is less than 5% of the approved estimated (DNIT) amount, the lowest bidder will have to deposit Quality Assurance Guarantee equal to the total cost of difference in the shape of CDR, Bank Draft & cashier's Cheque or Bank Guarantee from the scheduled bank as per clause 26 (A) within 15 days of issuance of notice or within expiry period of bid, whichever is earlier.
