## **GENERAL TERMS AND CONDITIONS**

- 1) Bidding documents including instruction to bidders can be downloaded up to one day prior from PHE web site (<a href="www.phedkp.gov.pk">www.phedkp.gov.pk</a>) only by the prequalified firms /contractor.
- 2) Financial bids must be accompanied by a bid security equal to 2% of the estimated cost of each scheme in shape of call deposit along with the stamp duty.
- 3) Incomplete/conditional bid or bid with unattested cutting/overwriting/disfiguring will not be accepted.
- 4) Technical bids will be opened at **02:00 PM** on **22.07.2024** in the office of undersigned in the presence of bidders or their representative opted to attend.
- 5) The Firms / Bidders who quote Rates up to a limit of 10% below Engineer Estimate shall submit bid security @2% only of Engineer Estimate as per KPPRA Notification.
- 6) The Firms / Bidders who quote Rates "More than 10% below up to 20%" on the BOQ shall Deposit 8% additional Call Deposit in addition to 2% bid security. Other conditions notified vide KPPRA Notification No: 6058-71 dated May 10, 2022 shall be intact.
- 7) Any other information regarding bidding may be obtained from the office of the undersigned on any working day.
- 8) Firm should provide all relevant attested documents of their registration.
- 9) All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services as listed in schedule-II of the Act ibid).
