1. Procurements shall be made under the Balochistan Public Procurement Rules – 2014.

**2. Eligibility of Bidders:**

- o Presence in Active Tax Payer List
- o The bidding firm must not be blacklisted by any procuring agency of Pakistan
- o Balochistan Revenue Authority Registration is required
- o The bidder must have completed 3 Assignment of similar nature of work
- o Turn over of at least 136,713,500 PKR Amount in 3 subsequent previous years showing financial capacity of the firm
- o Registration with Pakistan Engineering council (PEC) C-4 and above (Upto 200 million) In Relevant Category And Specialized Code is CE09(i) (Sewerage Works), CE09(ii) (Water Supply), CE10(i) (General Civil Engineering Works) , CE10(ii) (Slope Protection System), CE10(iii) (Concrete Repairs).
- o Registration with Pakistan Engineering Council (PEC) Relevant or Above Category and Specialized Code
- o Bid Security of 2% of Estimated Cost
- o Tender Processing fee of Amount Rs 2000 in account No C-02716 having Executive Engineer Road CWPP&H Department Musakhail
- o Only for the firms already engaged with Executive Engineer Road CWPP&H Department Musakhail , it is mandatory for them to provide performance certificate
- o ISO Certificate 9001 & 2015 Quality Management System
- o Turn over of at least 400 Million PKR Amount in 3 subsequent previous years showing financial capacity of the firm from audit Report, ICAP
- o Submission of audited balance sheets, for the last Three [03] years to demonstrate: The current soundness of the applicant's financial position and its prospective long term profitability, to evaluate;
- o Submission of audited balance sheets, Capacity to have cash flow reasonably enough to the cash flow requirements of meet the said works is:
- o Applicants and each partner to an application/ proposal should provide information on their current commitments on all contracts that have been awarded

or for which a letter of intent or acceptance has been received, or for Contracts approaching completion, but for which substantial Completion Certificate has yet to be issued. Note: Letter of Award / Acceptance must be provided with the Documents. Contract Identification, Name of Employer, Total Value of Work (Rs. in Million), Date of Start, Date of Completion, Average monthly invoicing over last six months (Rs. in Million), Leftover time in months, Average monthly invoicing of current commitment (to complete the balance work in time (Rs. in Million)

- the Bidder is required to submit a narrative outlining the method of performing the work.
- Pursuant to Sub-Clause 43.1 of the General Conditions of Contract, the Works shall be completed on or before the date stated
- The Applicant shall prepare an Application Submission Sheet using the form furnished. This Form must be completed without any alteration.
- The Employer reserves the right to obtain information regarding performance of the bidders on their previously awarded contracts/works. The Employer may in case of consistent poor performance of any Bidder as reported by the employers of the previously awarded contracts, inter alia, reject his bid and/or refer the case to the Pakistan Engineering Council (PEC). Upon such reference, PEC in accordance with its rules, procedures and relevant laws of the land take such action as may be deemed appropriate under the circumstances of the case including black listing of such Bidder and debarring him from participation in future bidding for similar works.
- Written confirmation (Power of Attorney) authorizing a person to submit the Bid. The Bid must accompany a power of Attorney issued by authorized representative of the Firm / company having the name and CNIC No of the person to whom Power of Attorney has been issued to Submit the bid to the Employer on behalf of the Firm / Company etc
- All Pending litigation shall in total not represent more than fifty 60% of the Bidder's net worth and shall be treated as resolved against the Bidder.
- All Non- performance of a contract did not occur within the last 5 years prior to the deadline for bid submission based on all information on fully settled disputes or litigation. A fully settled dispute or litigation is one that has been resolved in accordance with the Dispute Resolution mechanism under the respective contract and where all appeal instances available to the applicant have been exhausted.
- Not being under execution of a bid securing Declaration for last 4 years
- Applicants and all parties constituting the Applicant shall not have a conflict of interest. Applicants shall be considered to have a conflict of interest, if they participated as a consultant in the preparation of the design or technical specifications of the Works that are the subject of this prequalification. Where a firm, or a firm from the same economic or financial group, in addition to consulting, also has the capability to manufacture or supply goods or to construct works, that firm, or a firm from the same economic or financial group, cannot normally be a supplier of goods or works, if it provided consulting services for the contract corresponding to this prequalification, unless it can be demonstrated that there is not a significant degree of common ownership, influence or control.
