1. Procurements shall be made under the Balochistan Public Procurement Rules – 2014.

2. Eligibility of Bidders:

- o Presence in Active Tax Payer List
- o The bidding firm must not be blacklisted by any procuring agency of Pakistan
- o Balochistan Revenue Authority Registration is required
- o The bidder must have completed 1 Assignment of similar nature of work
- o Turn over of at least 235,600,000 PKR Amount in 3 subsequent previous years showing financial capacity of the firm
- o Registration with Pakistan Engineering council (PEC) C-3 and above (Upto 500 million) In Relevant Category And Specialized Code is CE04 , CE10 .
- o Has a Project Specific Bank Credit Line Facility / Available Cash in Account equal to the project cost; (Attach fresh Original Bank Credit Line Certificate mentioning Specific Project & Bank Certificate stating financial soundness & credit worthiness of Firm)
- o The contractor has not been blacklisted earlier by any government agency or private organization. In case of Litigations, History should be closed as per prescribed Performa (Attach affidavit on Rs. 100 nonjudicial stamp paper duly attested);
- o The amount of Bid Security shall be fixed. In case of absence of bid security, all such bids will be rejected. The Bid Security shall only be in the form of Deposit at Call or Bank Guarantee issued by a Scheduled Bank in Pakistan in favour of the Employer;
- o Submission of Tender Fee in shape of Green Challan in the NBP Khuzdar branch under Head of account C-03434 is mandatory
- o Must have an experience of at least 5 No's Projects of similar nature (i.e Dams) Completed in Last 5 Years. Minimum value of each project is 100 Million or Above.
- o Must have least 5 No's Projects of similar nature (i.e Dams) Currently In Hand. Minimum value of each project is 100 Million or Above.
- o Submission of Original CDR / Bank Guarantee and Green Challan with an application on firm's letterhead duly signed/stamped is mandatory to be submitted by Authorized representative of firm in the office on or before date of Online Bidding. Any firm not meeting the above mandatory requirements shall be declared Non-Responsive.
